The Committee will enquire into all complaints regarding Sexual Harrassment of the working women in the Directorate of Housing, Govt. of Meghalaya, Shillong and recommend suitable action of the matter.

The Member Secretary of the Complaints Committee will function as the Nodal Officer for the purpose of receipt of such complaints in so far the Directorate of Housing is concerned for placing and taking action of the complaints by the committee and then submit the report to the Director of Housing for further necessary action.

The Committee will also make an annual report to the Directorate of Housing and in turn Director will submit such report to the Government on all complaints received and action taken on these complaints.

The term of the Committee shall be for 3 (three) years from the date of issue of this notification.
