


Message


Message

PURPOSE OF THE ANNUAL REPORT

This Annual e-Report-2024 of the Directorate of Housing, Meghalaya, is an initial attempt to document electronically and serve as a significant milestone in the Department's initiative to highlight the Department's activities and achievements till date. Through this report, the Housing department aims to support the Government through its various welfare initiatives and to exhibit the Housing department's commitments towards integrity, efficiency, accountability in implementing schemes of the Government and to provide inclusive services to the community belonging to different categories. The report provides a brief overview of the department's history, highlighting its journey over the decades in promoting welfare schemes for the state's citizens. These welfare schemes are designed to support the well-being and development of the people addressing various aspects of their lives.

This report is a sincere attempt to provide a clear account of the department's activities, decision and operation throughout the year in maintaining accountability to its citizens. It is not just to provide retrospective insights which would be a crucial source of information in future, but also it can guide in 'future policy decisions' for improvements in the Department. In short, the Annual Report is not merely a bureaucratic exercise but also a vital tool for transparency, citizen engagement and informed decision—making.

Through the report, an attempt is being made to articulate the department's visions for the future. Adapting to the changing times, a new multi-pronged and multifaceted approach which is being planned while fostering inclusivity, equity and responsiveness to the evolving needs of the present. The Department's mission is to ensure financial stability to support the successful continuation of housing projects aimed at providing numerous housing projects for the citizens of Meghalaya across diverse income groups.

INTRODUCTION

Meghalaya, established as a separate state in the year 1972 after bifurcation from the erstwhile state of Assam. The department was then known as the Town and Country Planning Department (T&CP), which had begun as early as 1950's. The then T&CP department, Assam Government had schemes for building houses which were specifically meant for the Low-Income and Middle-Income Group by disbursing housing loans known as LIGH and MIGH schemes to the eligible individuals. Post statehood, it was bifurcated into two departments i.e. Housing Department and Urban Affairs Department in the year 1982.

During the 1970's, it was observed that a majority of the households especially in rural areas were mostly of temporary nature and people lived in 'kuccha houses and a substantial proportion resided in Assam- type houses which are 'semi-pucca' in nature. In the present scenario, a lot of changes are seen in housing. Both in the rural and urban areas, one can find different types of houses of various types and styles due to improved standard of living and income, however, there still remain a large number of poor families who live in kuccha houses who cannot afford a permanent shelter. Although homelessness is a global problem, however, the number of shelters less people in Meghalaya is comparatively low.

The previous schemes for the Low- and Middle-Income Groups inherited from the T&CP department were continued by the Housing Department, Meghalaya. In the later years, new schemes like EWS and LIG-NHP were also introduced in the year 1988-89 with comparatively lower interest rate. The aim of the scheme was to up-grade the house with more durable building materials, CGI sheets roofing materials were also provided to the beneficiaries in rural areas as majority are still economically unsound and to help cater to the housing requirements of the people to help improve the standard of living of the people.

The department had even introduced another scheme the **EWS-HIRE PURCHASED** scheme which was to improve the EWS category by purchasing land and build the house and allot to the deserving beneficiaries at an affordable rate and interest.

Rural Housing Scheme (RHS): This scheme was started since 1981-82 with the aim of providing durable roofing to the BPL/EWS families living in the stabilized rural villages of Meghalaya. Under this scheme, 3 bundles of CGI sheets were given as grant-in-aid to those who are able to construct their own houses up to roof frame level with their own resources. However, this scheme was discontinued from 2013 onwards as it was found in a study conducted by Program Implementation Department (PID), Govt of Meghalaya that the scheme was not viable for rural areas as the beneficiaries were not in a position to construct new house up to the roof level with their own resources. Later, another new scheme the CMHAP was introduced in the year 2017 which is still continuing till date.

Rental Housing Schemes (for Govt employees): - Understanding that many govt. employees posted in different district headquarters of the state do not have access to Govt. quarters due to scarcity and hence faced the problems of accommodation, this scheme was launched with the aim to bridge this gap. The department constructed Rental buildings in different districts to cater to the needs of the state employees. Besides, by way of the meagre rent collected from these rental units, it has also



served to contribute to income generation for the State exchequer too.

Meghalaya State Housing Board (MSHB): - Meghalaya State Housing Board (MSHB) was set up on the 26th January 1986 under the provisions of the Meghalaya State Housing Board Act 1986 with the aim to achieve the housing objectives by providing shelter to the poor and needy of the state. The Board was an autonomous body which was headed by the Housing Commissioner. External financial support was a necessity to enable the housing schemes to function well. Financial assistance was availed for the purpose by MSHB from external agencies like HUDCO, GIC, NIC and LIC with the sole aim of providing Shelter to the needy through the different schemes. From 1989-1990 onwards, housing loans were then being solely disbursed by the board. Through the years, many have benefitted from the MSHB loans. However, with the banks giving housing loans with higher loan amount at comparatively attractive interest rates, disbursement of loans by MSHB had gradually came down. Therefore, starting from the year 2000 onwards loans disbursement was discontinued and this has further led to the decline of the board too. As the board then became defunct the State felt that maintaining the board is not viable. Culmination in the PAC the MSHB was wounded up effectively from the 28th August,2024.





ONGOING SCHEMES OF HOUSING DEPARTMENT

With the rapid pace of urbanization, one of the biggest challenges is the availability of affordable housing in urban areas. The purchasing power, tenure of land, unavailability of flexible Housing finance system, lack of awareness about building technologies and paucity of public fund are results in inadequate housing habitat conditions especially for poor Economically Weaker Section. As a result, the gap between housing demand and supply has increased considerably. Keeping in view the importance of Housing in promoting health and status of living conditions of Meghalaya, the following are the ongoing schemes of the Housing Department:

I. Chief Minister Housing Assistant Program Scheme (CMHAP):

The improvement of the condition of the people also includes the provision of decent housing. The Chief Minister's Housing Assistance Program is divided into two components:

Component 1- in which 3 bundles of aluminum roofing materials are given as grant-in-aid to the Economically Weaker Section (EWS) families to improve their existing houses and

Component 2- is to provide a durable house to the Low-Income Group (LIG) families of the State, who are not in a position to build their own houses with their limited resources by providing financial assistance of ₹ 75,000/- (Rupees Seventy-Five Thousand) only to the eligible beneficiaries.


Objectives of CMHAP:

- To provide durable roofing materials to improve their existing houses to the
- Economically Weaker Section (EWS) and
- To provide dwelling houses for the Low-Income Group (LIG) families living in the State.


The scheme is implemented in both rural & urban areas of the State. Allocation of funds among the districts is based on the State Budget Allocation for the year. During the year 2022-2023, an amount of ₹163.00 crore only was earmarked under this program, of which, a total of 32,203 numbers beneficiaries had benefitted from this scheme. Further, during current financial year 2023- 2024 an amount of ₹69.50 crore only has been earmarked under this particular program. Tentatively, around 7400 numbers of beneficiaries will be covered during this financial year.

Picture: Showing the distribution of roofing materials to the selected beneficiaries under Component 1 of CMHAP





I. RENTAL HOUSING SCHEME:

The Rental Housing scheme was launched in the year 1991. The Rental Housing Scheme provides affordable, quality rental housing for government employees. Till date there are a total of around 37 buildings with a total of 65 units that were constructed in different districts of the state. (Graph 3). Based on the different categories of govt. employees, EWS/LIG & MIG buildings are allotted accordingly.








During this financial, the branch an amount of **Rs. 4,98,400/-(Four lakh ninety-eight thousand and four hundred)** only was collected for which represents rent recovery rate is only 43.74% **(Graph 4)**. A significant number continues to default on rent payment, the branch could not take proper legal action against the defaulter since there was no standing Rules in the Rental Housing Scheme before 2024. The department with the approval of Housing Rental Rules 2024, we hope to see improvement in rental collections.


The Research Branch (Rental) is responsible for monitoring the rent payments, identifying defaulters and informing the District Housing Officers to take necessary action to recover the outstanding dues. Now with the rules in place, the department would be able to streamline the allotment and ensure a proper control of the units. As rental buildings are in high demand, the Govt is planning even to extend the facility to the general public too and would include another category namely the High-Income Group too who are bonafide citizens of the state as part of the Housing Mission to be implemented in the future.

With the introduction of the new Housing Rental Rule 2024, the department expects to streamline and monitor more efficiently and work hard for timely recovery of rent. As the Department's goal is to achieve 100% recovery in coming years, this in turn would contribute to the revenue generation to the State's exchequer.

Graph 4: Scheme-wise Annual Turnover of Rental Housing Scheme during the year.



- **II. LOANS:** The **Loan recovery branch (LRB),** a specialized unit within the Housing Department, is entrusted with the critical responsibility of recovering outstanding loans and debts associated with various housing schemes in Meghalaya. The housing schemes under the LRB's purview includes loans of the:
 - i. Economically Weaker Sections (EWS)
 - ii. Low Income Group New Housing Policy (LIG-NHP)
 - iii. Low Income Group Housing Scheme (LIGH)
 - iv. Middle-Income Group Housing Scheme (MIGH)

DIFFERENT SCHEMES (since inception till date):

The current performance of loan recovery, both for principal and interest, across the four major schemes till date is outlined in Graph 5 below

CHALLENGES:

Despite the diligent efforts of the Loan Recovery Branch, several challenges continue to impede the timely and efficient recovery of loans:

- **Borrower Resistance:** Resistance from loanees regarding repayment, often due to economic difficulties or lack of understanding of their financial obligations, remains a significant hurdle.
- **Economic Instability:** Economic challenges, including inflation and low-income levels, make it difficult for loanees to maintain consistent repayments.
- **Resource Constraints:** The branch continues to operate under limited resources and manpower which restricts the scope of recovery efforts.
- Manual System Issues: The existing manual system of loan tracking is slow, prone to errors, and can affect the recovery of loan.

Deceased Beneficiaries: During the recovery drives there were many instances whereby the loanees have expired and the successors/children were not aware of the loans taken by the deceased beneficiaries and hence are not willing to shoulder the burden of not paying the loan.

I. RESEARCH BRANCH:

The Research Branch plays a crucial role in improving existing programs and identifying the challenges faced by the state of department.

The following were the activities undertaken during the year 2024:

- **i. Preparation of the Housing Mission Document**: In view of the emerging requirements for housing, the department is on a mission to start a housing mission which is in the preparatory stage of formulating the Meghalaya Integrated State Housing Mission (MISHOM).
- ii. Preparation of the Vision Document 2032: As the government is moving with a new perspective to achieve the Mission 10 billion economy target for the state, the Housing department too, in achieving affordable housing for all eligible beneficiaries and future needs of the general public of the state which are sustainable, inclusive and innovative ways in attracting investors which would bring about a transformation to the economy and promoting social welfare to the society at large. Thus, it will help to strengthen, expand the old schemes and widen the perspective of the mission.
- iii. **16th** Finance Commission: The write-up and necessary proposals were submitted by to the Housing department to the Planning Department for the 16th Finance Commission.
- iv. **Meghalaya State Housing Board**: The board was closed down on the 27th August, 2024 and 18 employees were given the 'Golden Handshake Scheme' by way of VRS.
- v. **Housing Rental Rules:** The Housing Rental Rules 2024 have been approved by the Govt. after indepth study, survey and scrutinization. With the new rule it would bring about conformity and uniformity in selection, allotment, rent fixation, rent recovery and penalization for non-payment of rent by allottees.
- vi. **E-Report:** Preparation of Annual e-report.
- vii. **Right to Information:** A total of 17 numbers of RTI's were received and 15 were disposed off during the year.



MAJOR ACHIEVEMENTS BY THE DIRECTORATE OF HOUSING DURING YEAR 2024

Loan Recovery Drive: As the MSHB had been defunct and through the years the recovery rate was almost 'NIL' hence as suggested by the PAC since 2014 for its closure, the Director of Housing had therefore directed the Housing Commissioner to restart the recovery drive and it was conducted during the month of December 2023 – March 2024 in all the districts of the state under the supervision of the District Housing Officers/ Housing Inspectors to sanitize the loan defaulters to repay back the loans which were taken during the year 1989 onwards.

As per the schedule planned by the Director of Housing, an 'aggressive loan recovery drive' which was headed by the district officers along with the staff of MSHB was conducted. Through this exercise, it revealed that most of the loanees responded positively and were willing to repay back the loan which the loanees/family members have barrowed. As per the records received at the Directorate, a substantial amount of ₹ 34,07,982/- (Rupees Thirty-Four Lakhs, Seven Thousand, Nine Hundred & Eighty-Two) only was recovered after the recovery drive (w.e.f December 2023 till date).



VOLUNTARY RETIREMENT SCHEME OF MEGHALAYA STATE HOUSING BOARD (MSHB)

The Cabinet had approved the closure of the Meghalaya State Housing Board in July, 2024 as suggested by the PAC. Voluntary Retirement Scheme (VRS) was granted to all the 18 employees of the board. On the 27th August, 2024 a 'Felicitation Ceremony' was organized at the Office Premises of the Meghalaya State Housing Board (MSHB), Madan Laban, Shillong by the Director of Housing for granting the Voluntary Retirement Scheme (VRS) to the Employees of the board for having voluntarily and gracefully accepting the winding up of the Meghalaya State Housing Board. The function was graced by Shri. Damanbait Lamare, MLA, Chairman of Meghalaya State Housing Board in the presence of other members of the Board, the Co- Chairman Shri. Kunal Ch. Momin and the Vice-Chairperson Smti. Hasina Yasmine Mondal.

The Housing Commissioner delivered her welcome address and introductory speech wherein she also briefed on the journey of the Meghalaya State Housing Board and the final winding up of the Board. Others who spoke on the occasion include Shri. F.M. Dopth, IAS Secretary to the Government of Meghalaya, Housing Department.











APPROVAL OF THE RENTAL RULES 2024:

The government had accepted the introduction of the 'Rental Rules 2024' in the month of October 2024 to cope up with the difficulties faced by the department in Rent recovery. Till then, there were no proper rules for the allocation of flats/units to the beneficiary. Rent rate fixation has also been framed along with rules for the process of eviction in case of non- clearance of rent or any other reasons.

- Meghalaya Right to Service Acts 2020: As mandated by the Meghalaya State Public Service Delivery (MSPSDC) Commission, the Housing department too have included the "Issuance of Non-receipt of Loan" Certificate for the timely service delivery to the public service to the citizen.
- **RTI 2024:** In compliance with the RTI Act the numbers of RTI's received during the year by the department is shown in the table below:

• **Floating of Tender:** To continue with the CMHAP Scheme for the year 2024, the office had floated a Tender on 10th September 2024 for a value of **Rs.69.50 crores**. 

WIM Re-selection and Nodal official selection for email ID creation and approval by the competent authority: Regarding the re-selection of WIM and Nodal Officer it was decided to be selected by the competent authority by October 2024. The same shall be provided for updation in the https://meghousing.gov.in website.
- 5. **Miscellaneous:** For the creation of websites, the pages have to reflect the Department's information and should be USER FRIENDLY too. From time to time a request is to be sent to NIC Coordinator Meghalaya for updating of all the pages in the websites. 
i. One day Workshop on Digital Government & Data management (Digital India) held on 7thAugust 2024 from 10 am to 5 pm at MATI.



Participants were Smti Jennifer B Khyriem R.A, Kum T.N Sangma and DHO, East Jaintia Hills district, Khlierhriat.



1. SUPERINTENDENT: "With the passage of time and with the introduction of the Information and technology in the workplace/office, the employees are entering into the fast-paced environment. To enable the employees to cope with the challenging times they require an extra additional effort and must ensure their performance to maintain a high level of efficiency in the office. Entering the new era of IT system, the employees must put on new ideas to take on new responsibility and it is necessary to attend training for improving and developing their skills".

2. RESEARCH BRANCH:

- **i.** With emerging technologies and the rising demand for accountability with efficiency, the workload has also greatly increased. Hence necessity for more skilled manpower is required.

- **v.** In order to strengthen the department, Capacity building measures are required to meet the objectives to help in managing, meeting of priorities and tight deadlines that arises from time to time.
- vi. Review the Housing Policies


3. LOAN RECOVERY BRANCH:

To further enhance the Loan Recovery Branch's performance and ensure greater success in loan recovery, the following recommendations are made:
